4. Approval of the June 19, 2019 and September 18, 2019 Meeting Notes

It was moved by Alternate Director Jimenez, seconded by Alternate Director Peschel and unanimously carried that the notes of the June 19, 2019 and September 18, 2019 meeting of the Advisory Committee be approved as presented.

5. Staff Reports

A. Planning and Implementation Contracts – Soua Lee reported that six projects were submitted for the Prop 1, Round 1 IRWM Implementation Grant solicitation, In February 2020, DWR recommended funding award of \$1,113,033 for the Fresno Metropolitan Flood Control District Basin "CF" Groundwater Recharge Flood Protection Project, which would provide a benefit to the community of Malaga. The other five projects were not recommended for funding. During the public comment period for the draft award recommendations, staff provided comments to DWR urging for a re-evaluation of scores which resulted in an overall proposal increase of 0.4, but was not enough to change the final funding award decision. Lee reported that through the Prop 1 DAC Involvement Program, Self-Help Enterprises developed a fact sheet for the Water Authority that may be used as an outreach tool. Lastly, Lee reported on the status of the Prop 1 Storm Water Grant Program.

- B. Inter-regional and Statewide Coordination Lee reported that the Water Authority provided support for the Roundtable of Region's joint letter to the State regarding the Governor's proposed Climate Resilience Bond which would allocate \$1 billion for IRWM and other programs and projects that achieve regional and inter-regional water resilience. Lee provided an update on new regulations through the CV-SALTS program that would require permitted salt and nitrate dischargers a new pathway for compliance, which is to choose between tougher nitrate requirements or participate in a Management Zone. Lee also shared information on the Water Blueprint for the San Joaquin Valley, a new economic report that seeks to highlight significant water challenges for California communities.
- C. Public Information The Committee approved the reconvening of the Outreach Workgroup to update the 2013 Kings Basin Water Authority highlight brochure to include recent accomplishments of the Water Authority.
- D. Legislation None to report.
- E. Administrative Items Lee provided a reminder that Statement of Economic Interests Form 700s must be filed with the Water Authority by June 1, 2020.
- *F. Other* None to report.

6. Request by McMullin Area Groundwater Sustainability Agency to become a Member Lee reported that the McMullin Area Groundwater Sustainability Agency (GSA) is a current Interested Party and is requesting to become a Member. Lee provided a boundary map to the Committee to illustrate the geographical location of the GSA. The GSA submitted a written request to become a member, completed the member questionnaire and adopted the JPA agreement. The GSA had previously adopted the updated 2018 Kings Basin IRWMP. General Manager Matt Hurley provided information on the GSA and reasons for why the GSA would like to become a member. The Committee discussed this request including voicing potential surface water and project concerns. It was moved by Alternate Director Jimenez, seconded by Director Fast and approved by a majority vote to recommend that the Board of Directors consider the request by McMullin Area GSA to become a member.

7. Consider IRWMP Boundary Expansion to include Non-Represented Areas

Lee reported that through the Prop 1 DAC Involvement Program, Self-Help Enterprises is developing DAC education and engagement materials. Part of their scope of work is to connect IRWM regions to nearby communities or tribes that do not have IRWMP coverage. Lee requested Committee consideration for outreaching to nearby communities including the City of Lemoore and the Santa Rosa Indian Tribe to inquire about any interest in participating with the Water Authority. If there is interest, it may include the potential expansion of the Water Authority's boundaries to cover those communities. It was moved by Alternate Director Desatoff, seconded by Director Stretch and unanimously carried that the Water Authority does not conduct outreach to nearby communities that does not have IRWMP coverage, but that those communities may submit a request to join.

8. Kings Basin Water Authority 2018-19 Annual Report

It was moved by Alternate Director Buche, seconded by Director Fowler and unanimously carried that the Kings Basin Water Authority 2018-19 Annual Report be approved as presented.
