## 4. Consider Approval of the October 20, 2021 Meeting Minutes

### 6. Advisory Committee Report

Chair Fast called on Advisory Committee Chair Jim Maciel to provide a report on Advisory Committee activities on March 16, 2022. Maciel reported that the Advisory Committee received staff reports, made a recommendation to the Board to add 16 new projects from Fresno Irrigation District to the Kings Basin IRWMP, and made a recommendation to the Board to consider a proposal by Wonder Media Group to develop a new website for the Water Authority.

Lastly, Lee provided an overview of the schedule and key dates for the Prop 1 Round 2 IRWM Implementation Grant solicitation.

Inter-regional and Statewide Coordination* – Lee reported that the IRWM Roundtable of Regions is in the process of developing a request for proposal to obtain a new Network Coordinator to assist with the administrative work of the Roundtable, build relationships with key local and state officials, and lead special projects.

# 8. Consideration to Extend Funding Commitment to the Roundtable of Regions with the Option to Modify Funding Commitment for FY 2023-24

Lee reported that the IRWM Roundtable of Regions is in the process of obtaining a new Network Coordinator. Jodie Monaghan, the current Network coordinator will retire on June 30, 2022. The Roundtable hopes to have a new Network Coordinator in place for the next two fiscal years but only have funding commitment from funding partners through Fiscal Year 2022-23. The Roundtable is requesting funding partners consider extending their funding commitment through Fiscal Year 2023-24. The Board discussed this matter and expressed support for the Network Coordinator's role to serve as an advocate for the IRWM Program. It was moved by Alternate Director Merritt, seconded by Director Burleson, and unanimously carried that the Water Authority pledge funding to the IRWM Roundtable of Regions for Fiscal Year 2023-24 for \$5,100.

# 9. Request to Approve Kings Basin Water Authority 2020-21 Annual Report

Lee provided an overview of the updates that were made to the Kings Basin Water Authority 2020-21 Annual Report. The Annual Report covered activities that commenced or was completed by the Water Authority Members and Interested Parties for Water Year October 1, 2020 to September 30, 2021. It was moved by Director Burleson, seconded by Alternate Director Stretch, and unanimously carried that the Kings Basin Water Authority 2020-21 Annual Report be approved as presented.

# 10. Request to Modify the Kings Basin IRWM Plan Project List and Kings Basin Storm Water Resources Plan Project List

Lee reported that the Advisory Committee provided a recommendation to the Board to add 16 new projects from Fresno Irrigation District to the Kings Basin IRWMP project list and Kings Basin Storm Water Resources Plan project list. The 16 projects includes a mix of expanding existing groundwater recharge basins and constructing new groundwater recharge basins. It was moved by Alternate Director Hall, seconded by Alternate Director Merritt, and unanimously carried that Fresno Irrigation District's 16 projects be added to the Kings Basin IRWMP project list and Kings Basin Storm Water Resources Plan project list.

# 11. Request to Rebuild the Kings Basin Water Authority Website

Lee presented a proposal by Wonder Media Group to rebuild the Kings Basin Water Authority website. The current website has widgets and themes that are no longer being supported by the developer and will eventually stop functioning. The Board discussed this matter and agreed to table this request until the next meeting. The Board provided direction to staff to obtain additional proposals to rebuild the Water Authority website.

# 12. Biennial Audit Report

Brian Trevarrow provided an overview of the Biennial Audit Report for Fiscal Years ended June 30, 2020 and June 30, 2021. It was moved by Alternate Director Merritt, seconded by Alternate Director Hall, and unanimously carried that the Biennial Audit Report be approved as presented.

Brain Trevarrow provided an overview of the quarterly financial reports for the period October 1, 2021 – March 31, 2022. It was moved by Director Burleson, seconded by Alternate Director Bessinger, and unanimously carried that the quarterly financial reports be approved as presented.
